- The purpose of the Forest Park Senior Center is to serve the Senior adults of Forest Park. The Forest Park Senior Center is supported by City of Forest Park, and membership fees.

Senior Center's Mission Statement

- The mission of the Forest Park Senior Center is to provide quality programs and volunteer opportunities in a caring and supportive atmosphere for individuals 55 and over.

Forest Park Senior Center Policies



- ◆ Only Senior Center members and their guests may participate in senior center activities.
- ◆ Each member is allowed 3 guest passes per calendar year for regular ongoing activities. Guest passes may not be used for trips. Any member violating membership rules/policies will be subject to having their membership revoked without refund.
- ◆ Full payment is due along with completed Membership Application. Membership fees will not be prorated.
- ◆ You must purchase/renew your membership at the Forest Park Tax/Finance Department located on the 2nd floor of the Municipal Building. Accepted payments: Cash, check, money order, Visa or Master Card, or mail a check made payable to City of Forest Park along with your membership application. There will be a \$25 charge for all returned checks.
- ◆ Residency will be verified by the Tax Dept. Each resident must be current on City taxes to purchase a membership.
- ◆ Those members who teach ongoing classes will have their annual membership fee waived for the duration of their assignment. If you begin teaching after you have purchased a membership, then your membership fee will be waived for the following year.
- ◆ Annual fees help to offset program costs. Fees are payable annually by January 15th of each new year. Renewals should be paid in full by January 15th of each new year. Your fees must be paid in order to receive special center mailings, participate in activities, events, and trips.
- ◆ Please inform the Recreation Coordinator of any name or address changes.



Senior Advisory Board

- ◆ Advisory Board members will serve to assist the Recreation Department in planning, coordinating, and implementing special events and additional programs.
- ◆ Senior Advisory Board—Made up of 15 senior center members; 11 resident members and 4 non-resident members. Meetings are held on the 2nd Friday of each month at 11:30 am in the 3rd Floor Conference Room of the Municipal Building. Members are selected on a first come, first served basis. Please see Recreation Coordinator if interested in filling a vacancy.
